## PRESIDENT'S REPORT

I am reflecting on my first year as President of the Maine Library Association and feeling proud to be a part of this hardworking team charged with the stewardship of our long-standing organization. I want to welcome Alisia Revitt, Mike Dignan, Pam Bonney, and James Higgins to the MLA Executive Council, and thank Ann Rea, Barbara McDade, Mamie Anthoine Ney, and Leigh Hallett for their years of service and thoughtful contribution to the board. It has been my pleasure to work with and learn from you.

We have had some turnover on committees and on the council as some of our long-serving and valued members retire from active service and as new members become more involved. Participation is always welcome, and more active members means that we can move faster and do more things. As an all-volunteer organization, we are all aware of the limits on our time that we all face, but becoming involved in your professional organization is a great way to build your network, expand your skills, be a leader, give back to the profession, and feel engaged in the community. I urge all members to look through some of the things MLA's committees have worked toward and accomplished this year, and join any committee which interests you. MLA had a slow financial year, with level membership and no income from the joint conference. Our income did not meet our expenses, but our savings was sufficient to cover the difference. I intend to be able to tell a very different story next year, as we have some changes coming to our membership structure, and anticipate some income from the MASL/MLA joint conference. We're hard at work planning the conference in Bangor at the Cross Center this coming November, and most of the pieces are already in place. We're inviting Eli Neiburger as our keynote speaker, and we'll be having a farewell reception for Edna Comstock and Linda Lord as part of the programming. We hope the conference can be used as a spring board to help us propel MLA to new heights.

In 2014, the Scholarship and Loan Committee gave a \$2,000 scholarship to Emma Gibbon, the Adult Services Librarian at Topsham Public Library. Emma is an M.S.L.S. candidate at Clarion University in Pennsylvania. She is an active member of the MLA Communications Committee and edited the MLAtOZ newsletter for almost three years.

The Committee encouraged libraries to note and celebrate “Choose Privacy Week” in May, and “Banned Books Week” in September. In addition, the Committee posted numerous updates about intellectual freedom matters to MELIBS, including several items and resources that deal with the tendency of libraries to “over filter” access to the web through library computers. The Committee is working with MASL to update the Intellectual Freedom Handbook, last updated over a decade ago. The hope is that it will be ready for presentation at the MLA/MASL conference in the Fall of 2014.

Four items that I really want to bring to the attention of MLA membership are:

**Resolution to formally allow programming at Midwinter Meetings** – There was a resolution at Midwinter (MW 40 Resolution to Allow Programs at American Library Association (ALA) Midwinter Meetings) to allow formal continuing education sessions at Midwinter, something traditionally associated with the ALA Annual Conference. This resolution will come back at Annual. So far the feedback I have gathered from Mainers is to oppose any move to expand Midwinter. This was also my initial inclination, so I intend to oppose the resolution when it comes back to us. The Councilor from Alaska has offered a counter amendment suggesting that Midwinter become a virtual meeting. I’m inclined to favor that motion.

**Lemony Snicket Prize for Noble Librarians Faced with Adversity** - This award approved by ALA Council See document at [http://www.ala.org/aboutala/sites/ala.org.aboutala/files/content/cd\\_36\\_Lemony%20Snicket%20proposal%20-%20FINAL.pdf](http://www.ala.org/aboutala/sites/ala.org.aboutala/files/content/cd_36_Lemony%20Snicket%20proposal%20-%20FINAL.pdf) It is the opinion of Lemony Snicket, author, reader, and alleged malcontent, that librarians have suffered enough. Therefore he, with the help of ALA’s Office for

Intellectual Freedom, will establish a new ALA award honoring a librarian who has faced adversity with integrity and dignity intact. The prize will be a generous amount of cash from Mr. Snicket's disreputable gains (\$3,000 + \$1,000 for travel), along with an odd, symbolic object from his private stash, and a certificate, which may or may not be suitable for framing.

**ALA Strategic Framework and Enabling Strategies** – There is wide agreement within ALA that our organization needs to change. The nature of that change has been subject to intense debate. Recently ALA President Barbara Stripling and the ALA Executive Board identified three areas and enabling strategies for closer examination by ALA Membership and posted related documents to ALA Connect:
